## Context Statement

Allenby Gardens Primary School caters for students from R-6. At the time of this report, the enrolment in 2023 is 401 . Allenby Gardens Primary School is classified as Category 5 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 1\% Aboriginal students, $9 \%$ students with disabilities, $26 \%$ students with English as an additional language or dialect (EALD) funded background, 1\% children/young people in care. Further information about the school is available on the school's website (including its context statement), as well as the My School website. The Preschool on site caters for 88 students. Currently we have a total of 489 students across the site.

## Governing Council Report

Dear School Community,
Welcome to the end of year report for Governing Council in 2023. In this report we'll reflect on a year of change in the school and in the operation of Governing Council. As always, student learning and engagement remained the foremost concern for the Governing Council with a focus on uplifting facilities and student experience across the school. We were briefed regularly on their activities and achievements, and celebrated the high standard consistently achieved by the students.

We recognise our teachers, the instructional leaders and coaches, who have continued to demonstrate their pursuit of excellence across the curriculum. We are very grateful to the staff for their unwavering commitment to learning outcomes and student wellbeing.

The values of 'our school, our community, our future' saw the Governing Council make a few notable changes and achieve some excellent outcomes, principally:

- Bringing back Vacation Care to the School, to provide a more supporting community during holiday periods for families.
- Supported the planned uplift of school facilities lead by the Strategy and planning Subcommittee designing a bright future for the school.
- The Fundraising Subcommittee continued to perform incredibly well, rising \$18,003.91 for the school across 10 events, as well as rising $\$ 1595$ for Childhood Cancer Research.
- Supporting the agreement to uplift the schools IT environment to provide an enhanced technology experience for students and teachers across the school, and
- Supporting the employment of a Support Officer to provide extra support to students in need within our community.

A review into the budgeting and reporting of costs was undertaken across the school, OSHC and canteen businesses, to improve consistency and the accuracy of forecasting across all three. The Governing Council also worked very closely with staff this year to refresh a number of school policies.

We would also like to thank all the members of Governing Council and the associated Sub-Committees for volunteering their time to support the administration of the school. We are confident that in 2024 we will continue to bring out the best in our students and our staff and continue to engage parents and the wider school community.

## Attendance Comment

In South Australia, preschool attendance is not compulsory, but it is strongly encouraged. Preschool gives children the best opportunity to develop skills, which prepare them for school. These benefits include establishing positive routines and habits, friendships and connections as well as developing communication, problem-solving and creative skills. All children are entitled to access a preschool program over 4 terms the year before they start school.

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or nongovernment school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
